Official Information Act request for correspondence with NZ Rugby regarding Sky TV

Thank you for your Official Information Act 1982 (the Act) request received on 21 October 2019. You requested:

Did anyone within the Ministry of Broadcasting, the Department of Prime Minister and Cabinet, or anyone in the Government for that matter, have any correspondence with NZ Rugby pertaining to the new 2020-2025 rights deal for All Blacks tests, Sanzaar and Mitre 10 Cup, prior to the deal being obtained by Sky TV officially on October 14?

And if so, what was the substance of those conversations, correspondence?

I note that you also sent your request to the Prime Minister's Office and understand they will provide a response to you separately.

We have undertaken searches of the Department of the Prime Minister and Cabinet's (DPMC) file management system and have not identified any documents within the scope of your request. Accordingly, your request for information is refused under section 18(e) of the Act as the document alleged to contain the information requested does not exist or, despite reasonable efforts to locate it, cannot be found.

I note your request is for correspondence held by anyone in Government. DPMC's principal role is provision of advice, on a daily basis, to the Prime Minister and Cabinet on issues that confront the Government.

DPMC is only able to assess your request in relation to information that we hold and are not able to assess potentially relevant information held by other Government departments.
