### Official Information Act request regarding lists of documents prepared for Ministers since September 2017

I refer to your Official Information Act 1982 (the Act) request received by the Department of the Prime Minister and Cabinet (DPMC) on 27 January 2021. You requested:

- "...the following information concerning the DPMC National Security Group.
- 1. Please provide a list of all reports and briefings prepared by the DPMC National Security Group for the PM and/or other ministers since September 2017, including the title, date, document number and type, and DPMC contact names.
- 2. Please provide a list of all cabinet papers prepared by the DPMC National Security Group for the PM and/or other ministers since September 2017, including the title, date, document number, and DPMC contact names.
- 3. Are there any categories of documents prepared for the PM and/or other ministers and, if so, please provide a list of all such documents prepared by the DPMC National Security Group for the PM and/or other ministers since September 2017, including the title, date, document number, and DPMC contact names..."

I note I last wrote to you regarding this request on 25 February 2021. In that letter, I advised I had taken the timeframe of your request to be from the date the previous Labour-led government was sworn in (26 October 2017), as I believe you are seeking information prepared for that administration, as well as the current one. I also advised that until 1 October 2020 the National Security Group (NSG) included an Emergency Management Policy team, that primarily supported the National Emergency Management Agency (NEMA) and its predecessor the Ministry of Civil Defence & Emergency Management (MCDEM), until the decision was made to formally move the team's function from NSG to NEMA. I noted that examples of items prepared by or relating to this team include items available at the following links:

I advised that I accordingly believe only items prepared by this team that are more closely connected to the functions of NSG than NEMA (or MCDEM) would be in scope of your request, and encouraged you to advise if I had misinterpreted your intent.

I further advised that, with regard to part one of your request, items prepared by NSG include a recurring document titled PM's Weekly Brief and provided a list of dates this item had been identified as being sent on. I also noted that, with regard to part three of your request, assessments are prepared within NSG by the National Assessments Bureau, and

withheld all information relating to these assessments under sections 6(a), 6(b)(i), and 6(b)(ii) of the Act.

Given the volume of information in scope of your request and consultations required, I also advised I was extending the time frame for responding to your request under section 15A of the Act by 50 working days. Following this extension, I am now in a position to respond further.

Please find enclosed lists of reports, briefings, and other similar items prepared by the National Security Systems Directorate (NSSD) and the National Security Policy Directorate (NSPD). In considering the scope of your request, I have taken cover briefings regarding draft responses to requests made to Ministers under the Act, and other items relating to Ministerial correspondence, to be out of the scope of your request. On occasion, items are jointly prepared by DPMC and at least one other agency. This list includes items where DPMC lead on preparing the advice; it does not include items where DPMC contributed less significantly on other agencies' material. Although efforts have been made to capture all documents in scope of your request, due to the volume, it is possible an occasional item may have been overlooked. Some information has been withheld, either in part or in full, under the following sections of the Act:

- Section 6(a), to protect the security or defence of New Zealand or the international relations of the Government of New Zealand;
- Section 9(2)(a), to protect the privacy of individuals;
- Section 9(2)(f)(iv), to maintain the confidentiality of advice tendered by or to Ministers and officials; and
- Section 9(2)(g)(i), to maintain the effective conduct of public affairs through the free and frank expression of opinion.

With regard to items related to Officials Committee for Domestic and External Security Coordination (ODESC) meetings, it may be helpful to note that written updates are not always provided, and that they can be replaced by verbal updates from the ODESC Chair to the Prime Minister. Where written updates have been prepared for the Prime Minister and other portfolio Ministers, I have decided to withhold the names of other portfolio Ministers these items were sent to under section 6(a) of the Act. The document ID from DPMC's document management system has been used as the sole numeric identifier for these items in this response. On occasion, items are jointly prepared by NSSD and the NSPD. Where this is the case, items have only been listed once.

In considering the listed recipients of items prepared by NSPD, the surname of the primary recipient/s listed in our administrative records has been provided. On occasion, the primary recipient/s of items can vary slightly as the document or situation evolves. I would accordingly note that it is possible the actual recipient may differ. If you would like confirmation of the details for specific items, including the portfolio capacity or capacities the recipient/s received the item through, as well as any other recipients the item was copied to, please advise. In considering items prepared by the National Cyber Policy Office, their Minister also receives regular status reports which are not included in this list. If you would like a list of dates such status reports were provided to Hon Clare Curran, Hon Kris Faafoi, and Hon Dr David Clark for the periods their respective Ministerial duties involved cyber security, please advise.

With regard to the parts of your request for "DPMC contact names", documents are typically from the Deputy Chief Executive or relevant Director, although on occasion a staff member acting for the Deputy Chief Executive or Director may approve an item on their behalf. With regard to NSSD items to the Prime Minister, these are typically from the Chair of ODESC or the Director of NSSD.

Given the volume of information your request involves, to identify the specific contact name/s for each item in scope of your request would require substantial collation and research. I have accordingly decided to refuse the part of your request for these specific details under section 18(f) of the Act, as the "information requested cannot be made available without substantial collation or research". If, following a review of the items in scope of your request, there are specific items you would like to have the contact details confirmed for, please feel free to make a request for that information under the Act. In the interim, I can advise the following roles relevant to your request are currently held by personnel as listed below:

- Chair of ODESC / Chief Executive of DPMC: Dr Brook Barrington
- Deputy Chief Executive, National Security Group: Tony Lynch;
- Director, National Assessments Bureau: Julian Grey;
- Director, National Security Systems: Marika Hughes; and
- Director, National Security Policy: Dan Eaton.

With regard to items prepared by the Emergency Management Policy team, on further consideration I have decided that all items prepared by this team related more closely to the functions of NEMA and its predecessor MCDEM. Accordingly, I have interpreted these items as out of scope of your request. You may be interested to know that many of these items relate to Ministerial Review: Better Responses to Natural Disasters and Other Emergencies in New Zealand, and the establishment of the National Emergency Management Agency. available these items publicly Several of are https://dpmc.govt.nz/publications/national-emergency-management-agency-proactivehttps://dpmc.govt.nz/departmental-agency/nema/ministerial-review-betterrelease. and responses-natural-disasters-and-other-emergencies.

In making my decision, I have taken the public interest considerations in section 9(1) of the Act into account.

You have the right to ask the Ombudsman to investigate and review my decision under section 28(3) of the Act.

This response will be published on DPMC's website during our regular publication cycle. Typically, information is released monthly, or as otherwise determined. Your personal information including name and contact details will be removed for publication.
