#### Official Information Act request relating to the convoy, protest and occupation of Parliament

I refer to your Official Information Act 1982 (the Act) request of 30 March 2022, transferred to the Department of the Prime Minister and Cabinet (DPMC) for response on 14 April 2022. You requested:

"... any internal communications, briefings, reports or communication relating to the convoy, protest and occupation of Parliament, sent or received by DPMC. This includes any material generated ahead of the start of the protest flagging up any risks or warnings."

We clarified the request with you on 21 April 2022 to exclude generic emails to DPMC staff regarding security and working arrangements during the occupation.

On 13 May 2022, we wrote to you extending the time limit for response by 20 working days, to 20 June 2022. The additional time was needed to complete consultation before a final decision was made on your request. I am now in a position to respond.

We have not included in this response emails circulating links or extracts from media articles relating to the Parliament occupation and protest. These articles are publicly available, and we did not believe this was the information you were seeking. Please advise if this is not the case. Further, we have taken the scope of your request to be for information prepared directly relating to the convoy and subsequent activity on the Parliament grounds in February - March 2022. Accordingly, we have taken the timeframe of material in scope of your request to be that prepared between late January and 30 March 2022.

#### Information Released

Identified as relevant to your request were some documents that largely covered matters out of scope of your request but contained some relevant information. These extracts have been provided as separate document in Appendix A.

Some information has been withheld, as marked, under the following sections of the Act:

- section 6(a), as disclosure would be likely to prejudice the security, defence or international relations of New Zealand: and
- section 9(2)(ba)(ii), to prevent damage to the public interest, where information was provided in confidence.

Also released to you as **Appendix B** is an email trail of 2 March 2022 titled "*Re: URGENT - update # 2*" received by DPMC and other agencies working on the Parliamentary complex from the Parliamentary Service. Some names and contact details have been withheld under section 9(2)(a), to protect the privacy of individuals.

#### Information to be made publicly available

There is some information relevant to your request identified in the COVID-19 Response Weekly Reports dated 4 March 2022 and 25 March 2022. These weekly reports are in the process of being proactively released on the Unite Against COVID-19 website. These reports will be made publicly available at: <u>covid19.govt.nz/about-our-covid-19-response/proactive-releases/reviews-and-audits</u>, where previous reports have been published. To the extent your request is for the information contained within these reports, it is refused under section 18(d) of the Act, as the information requested is or will soon be publicly available.

#### Information Withheld in Full

The Independent Police Conduct Authority (IPCA) has commenced an independent investigation and review of the policing of the occupation on and around Parliament grounds in Wellington during February and March 2022. Whilst this Review is underway information that relates to the issues under investigation and expected to be the subject of examination by the IPCA is being withheld to allow the Review to be completed.

Documents relating to a meeting of the Officials' Committee for Domestic and External Security Coordination (ODESC) are in scope of this part of your request. This includes meeting documents and a briefing. The information in scope is about matters relevant to the IPCA Review. Accordingly, this information has been withheld in full under section 9(2)(ba)(ii) of the Act to prevent damage to the public interest, where information was provided in confidence. In addition, due to the role DPMC holds in chairing ODESC, identified as potentially relevant to your request were administrative emails and messages, such as meeting arrangements, room bookings, timings and other arrangements. We have interpreted your request to not be seeking information of this nature. Please advise if this is not the case.

In addition, some email correspondence and messages have been identified that have information relevant to your request but also covering matters relevant to the IPCA Review, with some security summaries and the free and frank expression of advice. These have been withheld in full under the following sections of the Act:

- section 6(a), as outlined above
- section 9(2)(ba)(ii), as outlined above; and
- section 9(2)(g)(i), to maintain the effective conduct of public affairs through the free and frank expression of opinion.

There is some relevant information in two reports received by DPMC that are about disinformation and include information about the Parliament protest and occupation. This information has been withheld in full under section 9(2)(ba)(i) of the Act, to protect the supply of similar information in the future, where information was provided in confidence.

Because of the context, identified as relevant to your request was a report from DPMC's National Security Group of 9 March 2022 "*Policy Levers for Addressing Mis/disinformation*". This report is withheld in full under the following sections of the Act:

• section 6(a), as outlined above;

- section 9(2)(f)(iv), to maintain the confidentiality of advice tendered by or to Ministers and officials; and
- section 9(2)(g)(i), to maintain the effective conduct of public affairs through the free and frank expression of opinion.

We can confirm that there was some material produced by the National Assessments Bureau (NAB) identified as relevant to your request. This material contains information that, if released, would be likely to prejudice the international relations and national security of New Zealand. Accordingly, this information is withheld in full under section 6(a) of the Act, as outlined above.

There are some briefings provided by the DPMC Policy Advisory Group to the Prime Minister that have information relevant to your request. These briefings are provided to the Prime Minister in confidence in order to support her in her role as leader of the Government and chair of Cabinet. These briefings are withheld in their entirety under the following sections of the Act:

- section 9(2)(f)(iv), as outlined above; and
- section 9(2)(g)(i), as outlined above.

Where information has been withheld under section 9 of the Act, no public interest in releasing the withheld information has been identified that would be sufficient to override the reasons for withholding it.

You have the right to ask the Ombudsman to investigate and review my decision under section 28(3) of the Act.

This response will be published on DPMC's website during our regular publication cycle. Typically, information is released monthly, or as otherwise determined. Your personal information including name and contact details will be removed for publication.

Kia ora koutou,

Sorry for the late email. The additional security measures announced today will continue tomorrow to ensure the safety and security of everyone.

#### These include:

- Police will be present during the protest.
- The forecourt will be restricted to Police and Parliamentary Security only during the protest. A designated area will be set up for the media.
- Access to the buildings for cardholders is via the rear of Parliament (the external door by the gym in Executive Wing and the external door by the press gallery in Parliament House) and the Bowen House linkway.
- The main entrance, the rubber door and the Parliamentary Library (main door) will be locked for the duration of the protest.

- Visitors are directed to access the building through secure deliveries at the rear of Parliament, and their hosts will be contacted to come collect them. You are encouraged to hold meetings virtually if you can.
- There will be no vehicle access on the forecourt as all gates will be locked. We recommend vehicles use Museum Street and Ballantrae Place entrances.
- The dock way in EW and PH will be closed from 9:00am, and we will not be accepting any deliveries.
- If you are on precinct during the protest, please do not loiter near windows particularly in

areas like the level 1 bridge between the Executive Wing and Parliament House, or the black and white tiles.

• If you are able to work from home, please do so.

Remember to remain alert, stay safe, keep an active watch for any tailgaters, and report any suspicious behaviour to security immediately.
