Surveillance and Testing Le Mhatn Ora	•	•	<ul> <li>Te Whatu Ora closely monitors the Whole Genome Sequencing (WGS) process for positive PCR samples across the border, hospitals and community settings.</li> <li>With current numbers of arrivals, a sample of 300 provides a 95% assurance of picking up at least one copy of a variant, assuming a prevalence of 1% for that variant. The larger the sample size, the earlier a variant can be detected with greater accuracy.</li> <li>As previously reported, positive case numbers are trending down across the country, leading to less samples available for sequencing. The amber status reflects the impact of the decreasing case numbers and PCR samples available for WGS as targets for community case targets cannot be met. We anticipate, that with the shift of post-arrival testing no longer being mandatory, there will be some impact on the number of border cases available for sequencing. ESR will continue to sequence all border cases available, however it is expected there will be a natural decrease in samples available. We will monitor PCR testing and will work with ESR to understand the impact this may have on WGS.</li> <li>Since the week ending 24 July 2022, the total PCR cases reported have been declining steadily each week from around 4,000 COVID-19 cases reported per week with a positive PCR test, to 1,317 in the week ending 6 September 2022. Manatul Hauora have proposed shifting to a new community sequencing target to meet surveillance purposes of 500 samples per week. A paper was provided to your office on WGS Reporting on 2 September proposing this change.</li> <li>In the week ending 9 September, ESR requested 687 samples with 450 (66%) sequenced. This includes:         <ul> <li>194 (28%) imported cases;</li> <li>59 (9%) hospital cases;</li> <li>197 (29%) community cases; and</li> <li>237 (34%) samples that were not sequenced by the reporting period.</li> </ul> </li> <li>As previously reported, to improve the samples available, se</li></ul>

#### 3. Te Whatu Ora

#### 3.1 Items to Note/Updates

#### 3.1.1 COVID-19 Vaccination Insights

As at 11.59pm 12 September, 541,986 second booster doses have been administered, with 19,660 administered in the last seven days. A further 5,667 doses are booked in BookMyVaccine.

29.5% of all eligible Māori and Pacific people aged 50 years and older have received a second booster, an increase from 28.6% the previous week. For non-Māori non-Pacific aged 65 years and older, the rate is 54%, an increase from 52.9% the previous week.

For the week 5 September to 11 September, 67 national phone campaigns were undertaken to support population uptake on first and second booster as well as flu vaccinations, with a focus on those aged 50 and over, and prioritising eligible Māori and Pacific populations.

In total, 53,006 eligible people were called with 26.3% (13,954) answering these calls. Of those that answered, 1.1% (153) went on to book an appointment while 36.9% (5,160) advised they do not require assistance as they will attend a walk-in or manage this through their primary health provider.

#### International Pharmaceutical Federation World Congress of Pharmacy and Pharmaceutical Sciences

The 80th International Pharmaceutical Federation (FIP) World Congress of Pharmacy and Pharmaceutical Sciences is taking place in Seville, Spain from 18 to 22 September 2022. Three abstracts outlining the COVID-19 vaccines enhanced safety monitoring tools and the role of pharmacy were accepted in the campaign and are being presented as posters at the congress. The three abstracts being presented are:

- The community and hospital pharmacy role in Aotearoa New Zealand's COVID-19 vaccination programme.
- Enhanced Post-Marketing Surveillance of the COVID-19 vaccines in Aotearoa New Zealand.
- Active Safety Monitoring of the mRNA Pfizer-BioNTech (Comirnaty) Vaccine using a Recipient Survey:
   A New Zealand first.

Given the public attention around the novel COVID-19 vaccines and the scale of the COVID-19 Vaccine and Immunisation programme (CVIP), systems have needed to be continually reviewed and enhanced where possible, including vaccine safety monitoring systems and vaccine delivery options. This work was essential

for achieving high vaccination coverage. Ensuring effective dissemination of the work undertaken during the CVIP is key to communicating findings and sharing experiences and learnings on the global stage.

#### **Aged Residential Care facilities**

In the week starting 19 September, districts will provide a full update on progress of the second booster rollout to Aged Residential Care (ARC) facilities. The Programme has received some out-of-cycle updates, lifting facilities visited to 582 out of 668 (87%). The Programme continues to work with Districts to reconfirm their roll out end dates as ongoing COVID-19 outbreaks at facilities continue to disrupt outreach plans. Districts are undertaking repeat visits to ensure residents are vaccinated as they become eligible post infection.

#### **Second Boosters**

Alongside their fixed clinic operations, Health Districts with support from local Māori and Pacific Providers, continue to bring vaccinations to their most vulnerable communities. Highlights this week include pop-up clinics at Te Huinga Whetū and Angitu kapa haka competitions in the Nelson Marlborough and Canterbury Districts. While the focus of these clinics is reaching Māori tamariki with COVID-19 vaccinations, education is provided on the importance of other immunisations where appropriate. COVID-19 boosters will also be available to parents attending.

#### **Communications and Engagement**

Print collateral was updated to incorporate Medsafe's announcement of additional rare side effects of Nuvaxovid, with new material distributed for use in vaccination clinics and other health settings.

Communicating changes to COVID-19 vaccine mandate settings in the health sector has been completed, rolled out to the sector, trade unions, employers and workers and published online.

A small range of print and web material in Te Reo Māori has been shared with partners and health providers. New Pacific-targeted booster print collateral is also now available in English, Samoan, and Tongan, and is being shared with partners and health providers.

While the overall level of booster advertisements in mainstream media is now dropping, promotions are continuing to encourage people to get up to date with their COVID-19 vaccinations, including if they have recently had COVID-19.

The programme continues to use data and research to inform communications. Results from the August Horizon Māori Omnibus survey show that 80% of Māori who have had their first booster are likely to have a second booster if/when they become eligible. However, 51% of Māori who have had two primary doses but not yet received a first booster say they are unlikely to get one. The feedback also highlighted a preference for direct communication. This will be considered for the next phase of communications.

Direct marketing via SMS, email and posted letters continues weekly to inform people as they become eligible for a second booster, including a targeted communication to immunocompromised people.

#### 3.2 Equity

#### Māori Update

Maori health providers across the motu continue to run hauora events, where collective aspects of whānau hauora and wellbeing, including vaccination, are the focus.

#### Whānau Āwhina Plunket

Hauora o Toi is collaborating with Whānau Āwhina Plunket to target approximately 500 tamariki who are overdue for their childhood immunisations in the Eastern and Western Bay of Plenty. Bookings began on 5 September and vaccination clinics commence from 19 September.

#### Mā te kōrero ka eke

The Programme is working with 23 Kōhanga Reo across Te Waipounamu to plan and deliver 'Ora' initiatives. This will include vaccination services.

#### **Pacific Update**

Over the weekend of 10 to 11 September, 297 vaccinations (including COVID-19, influenza, MMR, and HPV vaccinations) were administered across Pacific vaccination events in Tāmaki Makaurau.

Over the previous two weekends, Tangata Atumotu Health held several youth-focused vaccination events and home mobile vaccination services in Christchurch.

Over the weekend of 3 to 4 September, the provider visited three homes and delivered 18 vaccinations. This consisted of 14 COVID-19 adult vaccines, three influenza vaccines and one MMR vaccine.

Over the weekend of 10 to 11 September, the provider visited 13 homes, and delivered 21 vaccinations: 16 Adult and three paediatric COVID-19, one influenza and one MMR.

Four further home visit clinics will be held across the rest of September.

#### **Disability Update**

COVID-19 Vaccine Uptake Among Mental Health and Alcohol and Other Drug (AOD) Service Users

As of 11 September, 86% of mental health and AOD service users aged 12 years and over had completed their primary course of the COVID-19 vaccine. Fifty-nine percent of this cohort who are eligible for a booster have received one.

When looking at COVID-19 vaccine uptake among those who solely use mental health services, compared with those who solely use AOD services, uptake is slightly higher for the mental health users, with 87% having completed their primary course of the COVID-19 vaccine compared with 82% of the AOD users.

COVID-19 Vaccine and Immunisation Peer Support Fund

24 applications for funding were received for the second round of the COVID-19 Vaccine and Immunisation Peer Support Fund. A panel was convened on Wednesday 14 September to assess the applications.



## 4. Managed Isolation and Quarantine Weekly Report



#### 4.1 Operational Update

#### 4.1.1 Invoicing

The table below shows the number of invoices issued as at 11 September 2022.

Invoices have various repayment terms depending on whether they are a sports group (10 days), critical worker (30 days) or standard returnee/maritime crew/aircrew (90 days).

Please note that for all arrivals from the 20 August 2021, all invoicing had payment terms of 30 days except for sports groups under Crown Service Agreements who have 10 days.

#### 4.1.2 Debt Recovery

The debt recovery percentage remains at 86%, which is against our nominal target recovery of 90%.

As of 11 September, 15,179 invoices worth \$45.8m have been passed to our debt partner. In addition:

- \$19.3m has now been paid (an increase of \$308k).
- A further \$383k of debt is under instalment and is expected to be converted to payments over coming
  weeks
- There are 197 active fee waiver requests, while applications are processed, they are recorded as outstanding debt.

#### 4.2 Ombudsman Complaints

As at 7 September there are seven active investigations:

- one is on policy advice;
- two are on emergency allocations;
- one is on exemptions from managed isolation;
- one is a declined undue financial hardship fee waiver application;
- one is about facilities; and
- one is the Chief Ombudsman's self-initiated investigation.

To date, 258 investigations have been closed, with the Chief Ombudsman issuing 123 opinions in MBIE's favour and eight final opinions against MBIE.

There are 93 preliminary enquiries. Preliminary enquiries are cases where the Ombudsman requests the file to assess the complaint and determine next steps.

# BORDER EXECUTIVE BOARD

### 5. Border Executive Board Report

This update is provided to you as the responsible Minister for the Border Executive Board.

#### 5.1 Items to Note/Update

#### 5.1.1 Border Executive Board Meeting

The Board are next due to meet on 21 September 2022 and will discuss the progress of the New Zealand Traveller Declaration and will receive updates on Border forecasts and scenarios and the Maritime Border Programme.

#### 5.2 Maritime Border Programme

The significant implications of the decision to move to a Post-Winter Strategy for the maritime border include:

- The revocation of the Maritime Border Order (MBO) as of 11.59pm Monday 12 September 2022
  - Vessel categories 1 and 2 (as were defined in the MBO) cease to exist with the associated entry processes and requirements including vaccination and testing removed.
  - Operational processes and vessel management for all vessel categories return to businessas-usual agency functions.
- COVID-19 positive cases will be required to self-isolate for seven days however close-contact isolation requirements cease to apply. Testing will be encouraged, and RATs will made available for cruise passengers by Customs.
- No contact tracing requirements are in place at the maritime border.
- The New Zealand Traveller Declaration (NZTD) maritime solution will not be implemented for cruise season 2022/2023. This means travellers arriving to New Zealand by sea will not have to complete a NZTD until the Tranche 3 rollout \$9(2)(f)(iv)
- Director General Notice on Pratique remains in place continuing the direction that COVID-19 presence onboard vessels is not a reason to withhold pratique.
- Operational border agencies have confirmed there are no significant issues to report as processes at the maritime border return to BAU.

# 6. New Zealand Customs Service Weekly Report



#### 6.1 New Zealand Traveller Declaration

Following the removal of the COVID-19 Protection Framework, Customs undertook a range of activities to ensure travellers, airlines and multi-agency border operational staff were informed about the changes to requirements to enter New Zealand by air. The required changes to New Zealand Traveller Declaration were made without incident.
