Report on Overseas Travel: Rt Hon Jacinda Ardern and cross-party delegation

I recommend that Cabinet note this report on my travel to Apia on 1 – 2 August.

# Report

- I visited Samoa to commemorate the 60<sup>th</sup> anniversary of the signing of the Treaty of Friendship between Samoa and New Zealand. It was my first official visit to Samoa since the start of the COVID-19 pandemic.
- I was accompanied by a 60-strong travelling party comprising cross-party parliamentary delegation; representatives from the Māori and Samoan communities; and New Zealand and Samoan media outlets.
- Throughout the visit, Prime Minister Fiame Naomi Mata'afa and I reiterated our countries' enduring commitment to the Treaty of Friendship, acknowledging the growth of our relationship over the last 60 years, and recognising our mutual desire to continue working closely together.

## Official reception

- Acknowledgement of our shared history and shared future was underscored in my and Prime Minister Fiame's keynote speeches during the official reception. We affirmed a renewed commitment to the principles of the Treaty of Friendship: between two governments of "sovereign and equal status" founded on respect for human rights and "the purpose and principles of the Charter of the United Nations". We acknowledged the relationship founded on "friendship, confidence, and a mutual endeavour to obtain for our peoples fuller opportunities for social progress", and committed to maintain and strengthen the bonds between our two countries.
- In our speeches, we recognised that our shared story had not always been exemplary, and that we may still have some hiccups, but that there was a mutual understanding that there was always space to talanoa and keep dialogues open. Prime Minister Fiame and I both noted that the relationship continued to thrive through honest, frequent, and equal dialogue.

## Meeting with Samoa's Cabinet

In a special gesture by Samoa, cross-party representatives from New Zealand, including the National, Green, Act and Māori Parties, were invited to participate in a meeting with Samoa's full Cabinet – the first meeting of this kind in recent memory. This was a warm and engaging dialogue, characterised by a notable level of trust between Parliamentarians, as well as

a genuine and open conversation and free flow of constructive ideas. Importantly, there was a united commitment from New Zealand's cross-party Parliamentary delegation to support Samoa's aspirations and vision of "a Samoa where people want to stay".

Rebuilding the tourism sector to ensure it was high quality was also a key focus. Affordable flight connections were an important issue, <sup>s6(a)</sup>

#### **Announcements**

During the visit, I announced New Zealand support for Samoa's infrastructure priorities by committing to co-fund the rebuilding of the Savalalo Market in central Apia at a cost of NZ\$12 million. I also announced NZ\$15 million in flexible financing to support implementation of Samoa's climate change priorities.
