### Report on Overseas Travel: Rt Hon Chris Hipkins

I recommend that Cabinet note this report on my travel to Australia on 7 February 2023.

### Report

- 1 I travelled to Canberra, Australia on 7 February 2023 for a one-day visit to meet Australian Prime Minister Anthony Albanese and representatives of the business community.
- 2 This was my first international trip as Prime Minister, which followed the custom of New Zealand Prime Ministers prioritising early engagement with Australia. The purpose of the visit was to build a relationship with Prime Minister Albanese and to lay the groundwork for further high-level political engagement with Australia this year.
- 3 The visit marked the start of a milestone year for the Australia-New Zealand relationship: in 2023, we will celebrate 80 years since the opening of our respective diplomatic missions, 50 years of the Trans-Tasman Travel Arrangement, and 40 years of the Closer Economic Relations (CER) agreement.

I accompanied Prime Minister Albanese to the House floor, where I had the opportunity to meet Representatives including most of the front bench of the Labor Government, former Prime Minister Scott Morrison, current Opposition Leader Peter Dutton, and former leader of the Nationals Party Barnaby Joyce. I also met separately with the President of the Senate Senator Sue Lines and the Speaker of the House of Representatives Hon Milton Dick.

- 7 I attended a business roundtable event co-hosted by the Trans-Tasman Business Circle to discuss Australia-New Zealand business priorities. Business representatives (which included Bunnings, Woolworth, Australian Bankers Association, Fortescue, Fonterra, Ryman Healthcare, Xero, and Fulton Hogan) raised issues spanning the difficult economic environment, deteriorating social cohesion, and challenges and opportunities associated with climate change adaptation. Businesses expressed interest in Government support to improve the digital business environment. There will be the opportunity to engage on these issues further at the Australia-New Zealand Leadership Forum in Wellington in July 2023.
- 8 Between these engagements, I participated in a joint press conference with Prime Minister Albanese and had an interview with Australian nightly current affairs programme 730.
