Purpose

1. This aide-mémoire provides you with information on the upcoming hui with Christchurch communities to discuss the government's response to the Royal Commission of Inquiry into the terrorist attack on Christchurch masjidain on 15 March 2019 (the RCOI).

Background

- You have agreed to meet with Christchurch communities to discuss the government's response to the RCOI. This meeting follows through on your promise to the affected whānau of the 51 shuhada and survivors, and the Christchurch communities engaged with in 2021 more broadly, to keep them informed of the progress being made and to ensure their needs are met.
- 3 Previous advice to the Lead Coordination Minister for the RCOI response noted that any engagement in Christchurch about the RCOI response should include Christchurch-based ethnic and faith communities. As such, invitations were extended to both Christchurch-based ethnic and faith communities, as well as the affected whānau, survivors and witnesses.
- 4. The purpose of this hui is to:
 - a) listen to the communities' feedback about the ongoing implementation of the RCOI response;

- provide a progress update and forward look at what is coming up across the RCOI response work programme; and
- c) reaffirm your commitment to keeping those affected by the attack, and the Christchurch Muslim, ethnic and faith-based communities, at the centre of the response.

Key event details to note

- The hui will be held on Saturday 3 September, from 9.30am 3.30pm, at the Addington Raceway & Events Centre in Christchurch.
- 6. This paper provides:
 - a) context on issues that participants are likely to raise or may be interested in;
 - b) an agenda and summarised list of attendees (Attachment One);
 - c) suggested talking points for your opening addresses (Attachment Two and Attachment Three); and
 - d) background context and reactive talking points (Attachment Four),
- 7. The hui will comprise of two sessions:
 - a) a conversation with affected whānau, survivors and witnesses in the morning (9:30am-12:00pm); and
 - b) a conversation with Christchurch-based ethnic and faith communities in the afternoon (1:30pm-3:30pm).
- Affected whānau, survivors and witnesses may choose to stay on from the morning session or prefer to attend the afternoon session instead. Whilst they are welcome to register their interests to do so in advance, participants will not be encouraged to attend both sessions.
- 9. The morning session will be shared via videolink for participants that are not based in Christchurch or are unable to attend in person. Through the registration process, DPMC received requests for travel assistance from affected whānau based in the United Kingdom and Auckland. These individuals have sought assistance to participate in conversations in the past and have been disappointed at the lack of opportunities to engage with Ministers. Given this, officials have advised sharing the session via videolink will best meet the needs of these individuals whilst balancing the costs. The hui will be streamed on Zoom as a webinar giving participants the opportunity to use the chat function to ask questions but not speak directly via Zoom.
- 10. Chris Mene (facilitator) will open and close each session with a karakia and manage the Q&A session. He will also invite an appropriate member of the Muslim community to open and close with a dua at each session. Chris has facilitated a number of engagements with the Christchurch communities since the attacks and is well known amongst the Muslim community.
- 11 Senior officials from key RCOI response agencies, local MPs and Mayor Lianne Dalziel are also attending.
- 12. Interpreters, psychosocial support staff, childcare providers, case managers from the Ministry of Social Development, and operational managers from Immigration NZ will also be present, to provide support and answer questions relating to individual cases.
- 13. Security has also been arranged given the scale of the event.

What communities are likely to ask

14. The hui will provide participants with an opportunity to engage directly with Ministers and senior government officials, ask questions, and raise any concerns they may have about the government's response to the RCOI Report. Each session allows time for participants to ask Ministers and officials questions in an open forum, followed by an opportunity for Ministers and officials to mingle with attendees.



- 16. The afternoon session (with pan ethnic and multi-faith communities) is likely to focus on the RCOI response more generally. Participants may also raise questions around other government responses to the housing crisis, immigration reforms and requests for sharia banking.
- 17. Background context and talking points covering these issues is set out in **Attachment**Four. The talking points are grouped by portfolio where possible.
- 18. Senior officials from the following agencies will be available to address subject matter specific questions if required: Ministry of Social Development, Ministry for Ethnic Communities, Department of the Prime Minister and Cabinet, New Zealand Security and Intelligence Service, Ministry of Justice, Department of Internal Affairs, New Zealand Police, Ministry of Education, and Immigration New Zealand.

Providing an update on the progress being made on the RCOI response

- 19. The second objective of the hui is to update attendees of the progress being made by government on the RCOI response.
- 20. A one-page summary of the work underway will be provided to all attendees on the day and the opening address will provide both Ministers with an opportunity to highlight the work that has been done and is underway.
- 21. Attendees are likely to have questions on the progress made and may seek updates on where key workstreams are at. These are likely to focus on:
 - a) progress on the national security sector reforms;
 - b) incitement of hate speech work programme being led by the Ministry of Justice;
 - c) work relating to the National Action Plan Against Racism; and
 - d) the social cohesion work programme being led by the Ministry of Social Development.
- 22. Key achievements and updates from the last year have been included in your opening remarks. Additional talking points for other recommendations that may be of interest to attendees are covered in **Attachment Four**. The talking points are grouped by portfolio where possible.
