Covid-19 Independent Continuous Review, Improvement and Advice Group

The Covid-19 Independent Continuous Review, Improvement and Advice Group was first convened on 2 November 2022. The last meeting was held on 30 June 2022. You can read the meeting notes for this meeting at www.dpmc.govt.nz/publications/covid-19-independent-advisory-groups

The members of the group were Sir Brian Roche (Chair), Dr Dale Bramley, Dr Debbie Ryan, Professor Phillip Hill, and Rob Fyfe. The purpose of the group was to provide advice to the Minister for COVID-19 Response on specific areas of the response where improvements could be made with the benefit of alternative and independent perspectives.

The key focus areas for the group included considering COVID-19 response efforts across the Government's system-wide response, such as border, managed isolation and quarantine, and public health response. In addition, the group gave an independent perspective on the robustness of the COVID-19 response system and opportunities for continuous improvement on specific aspects of the response.

The Strategic Covid-19 Strategic Public Health Advisory Group

The Strategic Covid-19 Strategic Public Health Advisory Group was first convened on 31 March 2021, and the final meeting was held 14 December 2022.

The chair of the group was Professor Nikki Turner, and the members of the group were Professor David Murdoch, Dr Ella Iosua, Dr Maia Brewerton, Professor Patricia Priest, and Associate Professor Matire Harwood.

The group's purpose was to provide independent advice on the COVID-19 response, informed by their expertise in epidemiology, infectious diseases, public health, and modelling. The key areas of focus of the group were to have a particular regard to public health protections and border and community surveillance settings, within the context of the risk of new variants, and to reduce inequitable outcomes for vulnerable populations.
