## Official Information Act request relating to the cost and purpose of events

Thank you for your Official Information Act 1982 (the Act) request received on 10 August 2023. You requested:

"Can I please request under the Official Information Act:

• A list of all events the department has held or had some responsibility for hosting that cost in excess of \$10,000 over the past year? Can the total cost for each of these events please be provided, along with a breakdown of what contributed to the costs? It would be helpful to also know the business purpose or justification for each event as well."

As advised in our letter of 7 September 2023, the time limit for deciding on your request was extended by an additional six working days under section 15A of the Act. This extension was required because of the consultations needed to make a decision on your request.

The consultations have now been completed and I have decided to release the requested information to you.

### Our response

We have identified three events which the Department of the Prime Minister and Cabinet (DPMC) held or had some responsibility for hosting between 10 August 2022 and 10 August 2023, that are in scope of your request.

Responsibility for all three identified events sat with DPMC's National Security Group which provides leadership across New Zealand's national security community to strengthen national resilience, develop situational understanding and improve coordination and collaboration on issues of national significance.

### He Whenua Taurikura hui: 30 October – 1 November 2022

The Counter-Terrorism Hui, He Whenua Taurikura, is a conference-style event that brings together government agencies, academics and researchers, businesses and private sector organisations, communities, and civil society to discuss issues related to countering terrorism and violent extremism.

This initiative was in response to recommendation 16 from the Royal Commission of Inquiry into the terror attack on Christchurch masjidain on 15 March, that Government host an annual hui to create opportunities to build relationships and share understanding of countering violent extremism and terrorism.

It was funded through Budget 2022 <u>B2 Wellbeing Budget 2022 - A Secure Future - 19 May</u> 2022 (treasury.govt.nz). The Government announcement can be found on Page 141: The 2022 hui was hosted in Auckland from 30 October - 1 November with approximately 300 in person participants. The purpose of this Hui was to pursue a safer New Zealand, with a focus on prevention of violent extremism and terrorism. The conference event included a mix of keynote and research presentations, panel discussions, interactive workshop-style sessions, and a scenario-based tabletop exercise. The event featured a keynote speech from the Prime Minister. The event was attended by media and livestreamed to enable inclusion from those that could not attend in person.

This annual event has been an important way to build trust and confidence with communities, increase transparency in counter-terrorism work and build partnerships to counter terrorism and violent extremism. Given the diversity of participants, an in-person event is key to achieving this to break down barriers and build meaningful and sustainable relationships for engagement.

A significant proportion of the budget is allocated to travel and accommodation of participants, drawn particularly those from at-risk and affected communities. Many community organisations and community representatives are voluntary and non-paid, and covering costs of travel and accommodation supported their participation.

The hui was hosted by DPMC, with support from the Visits and Ceremonial Office of the Department of Internal Affairs (DIA).

## Cyber Policy Forum: 7 – 9 December 2022

The Cyber Policy Forum enables Five Eyes policy counterparts, from New Zealand, Australia, Canada, United Kingdom and United States, to collaborate and exchange information on cyber policy issues, with a particular focus on the alignment of strategies and policies to deter and respond to malicious cyber activity. The forum involved approximately 25 core participants and supporting officials.

The forum Chair rotates on a 12-monthly basis and each Chair is expected to host one inperson meeting during their term.

The hosting of this meeting with Five Eyes counterparts aligns with the international pillar of the Cyber Security Strategy ("internationally active") and is an important part of New Zealand's approach to strengthening cyber resilience.

### The Five Country Ministerial: 26 – 28 June 2023

The Five Country Ministerial (FCM) is an annual meeting of the home affairs, interior, security and immigration ministers of Australia, Canada, New Zealand, the United Kingdom and the United States of America to discuss national security challenges of mutual interest and concern.

New Zealand hosted the FCM in Wellington from 26-28 June 2023. This was the first time New Zealand hosted the in-person meeting. The FCM involved approximately 70 participants from FCM countries, including four Ministerial-level visitors.

The Minister for National Security and Intelligence allocated responsibility for representing New Zealand at the FCM to the Minister of Immigration, Hon Andrew Little. DPMC and the Ministry of Business, Innovation and Employment, with the support of the Visits and Ceremonial Office of DIA, led on delivery of the ministerial meeting.
