Official Information Act request for correspondence with consulting firms between 14 October and 31 December 2023.

Thank you for your Official Information Act 1982 (the Act) request received on 10 January 2024. You requested:

Please supply the following information held by the Department of the Prime Minister and Cabinet under the Official Information Act:

Any correspondence (inbound and outbound) between DPMC and consulting firms (and their employees), such as Deloitte, KPMG, PWC, Boston Consulting Group, McKinsey, Bain, Martin Jenkins, Allen + Clarke, Ernst & Young, between 14 October and 31 December 2023.

Please let me know if you require any further information to process this request.

On 12 January 2024, we asked you to refine your request because searches would need to be completed across all electronic systems belonging to the Department of the Prime Minister and Cabinet (DPMC), including all staff email addresses, to identify relevant material. This would require substantial collation and research.

On 25 January 2024, you replied, refining your request to include:

Any correspondence (inbound and outbound) between DPMC senior managers (namely Rebecca Kitteridge, Julian Grey, Janine Smith, Rachel Hayward, Clare Ward, Stephen Crombie, Katrina Casey) and consulting firms (and their employees), such as Deloitte, KPMG, PWC, Boston Consulting Group, McKinsey, Bain, Martin Jenkins, Allen + Clarke, Ernst & Young, between 14 October and 31 December 2023.

We are now in a position, to release to you information pertaining to your refined request.

I have decided to release the relevant email communications, subject to information being withheld under the following sections of the Act:

- section 9(2)(a), to protect the privacy of individuals
- section 9(2)(b)(ii) would be likely to unreasonably to prejudice the commercial position of the person who supplied or who is the subject of the information
- section 9(2)(g)(ii), to prevent improper pressure or harassment.

A small amount of information has been deemed as out of scope of your request and is marked accordingly.

In making my decision, I have considered the public interest considerations in section 9(1) of the Act. No public interest has been identified that would be sufficient to override the reasons for withholding that information.

You have the right to ask the Ombudsman to investigate and review my decision under section 28(3) of the Act.

This response will be published on DPMC's website during our regular publication cycle. Typically, information is released monthly, or as otherwise determined. Your personal information including name and contact details will be removed for publication.



Thanks for the conversations last week about our session tomorrow from 10:30am-12:00pm (NZ time). Below is a list of the people we expect to attend (pending

calendars and events of the day).

As discussed we are interested in exploring the Delivery Unit model. We would like to understand its applicability in the Westminster system and in advanced democracies. We are aware of the Asian and Middle Eastern models but there are aspects of their political systems that are distinct and we'd like to understand how the model works in political systems similar to our own.

Below are a couple of bullet points that would be helpful to cover:

- Countries we are interested in are Canada, UK and Australia. There may be
 other western democracies that are also applicable so feel free to include. If you
 have any knowledge of Denmark that would be great.
- Examples of how the model works including governance, reporting to the PM, and how the Unit engages with central functions such as policy and treasury functions
- How it works with PMO type functions i.e. if the Delivery Unit focuses on the top 5-10 targets, but the Govt also wants a central function to also track their 100+ targets
- Engagement of the Prime Minister e.g. cadence, style and approach for the 'stocktake' type meetings with other Ministers
- Example of how the Delivery Unit has moved a metric by going down into the delivery chain and working with stakeholders etc., i.e. what makes it different from an assurance function
- · What works, what doesn't
