#### Official Information Act request: Material regarding appointment or function of PMCSA

Thank you for your Official Information Act 1982 (the Act) request received on 22 October 2024. You requested:

"Copies of all and any reports, briefings, documents, memoranda, correspondence, legal advice or emails in direct regard or including specific mention of the appointment and function of the Prime Minister's Chief Science Advisor, from the 2024 calendar year. This includes briefings to relevant ministers of the change, along with communications with any and all outside parties. These requested documents include one titled Briefing: Prime Minister's Chief Science Advisor Appointment (dated 6 May 2024) and advice from the Policy Advisory Group."

I have interpreted your request to be for information held by the Department of the Prime Minister and Cabinet (DPMC) about the appointment of a new Prime Minister's Chief Science Advisor (PMCSA) or the scope of the PMCSA role, dated from 1 January to 22 October 2024 (the date of your request). I have therefore excluded purely administrative emails (Official Information Act requests from other journalists, arranging meeting times, and the like), correspondence with applicants for the role, and correspondence about the work undertaken by either the PMCSA or their office.

I am also aware that you have made a similar request to the Prime Minister. As some of the information you have requested is held by both the Office of the Prime Minister and DPMC, where such information was produced by the Office of the Prime Minister and/or is more closely connected to the Prime Minister's functions, it will be addressed in the response from the Prime Minister's office (PMO) to you. I therefore refer you to the response to your request to the Prime Minister.

#### Information to be released

I have decided to release the relevant parts of the documents listed below, subject to some information being withheld. The relevant grounds under which information has been withheld are:

- section 9(2)(a), to protect the privacy of individuals
- section 9(2)(f)(iv) to maintain the confidentiality of advice tendered by or to Ministers and officials
- section 9(2)(g)(i), to maintain the effective conduct of public affairs through the free and frank expression of opinion.

Item 1 is an email chain that summarises a meeting between the Prime Minister and Sir Peter Gluckman on 8 February 2024, and is being provided to you as a summary as permitted under section 16(1)(e) of the Act. The meeting included a discussion of the PMSCA role and appointment process, amongst a number of other agenda items. The summary was sent internally within DPMC to the Policy Advisory Group (PAG) mailing list and Rebecca Kitteridge on 13 February 2024. It was then forwarded from PAG to the Prime Minister's Office on 14 February 2024.

### Information to be withheld

The appointment of the PMSCA remains under active consideration. Therefore, under section 9(2)(f)(iv) of the Act, I am withholding in full:

- an Appointments and Honours Committee Cabinet Paper, undated, and three email chains relating to this document, dated 7, 8 and 13 May 2024 respectively
- the draft report of the Science System Advisory Group, dated August 2024
- the document "Briefing: Prime Minister's Chief Science Advisor Appointment" dated 6 May 2024, and two email chains relating to this document.

These documents are withheld to maintain the confidentiality of advice tendered by or to Ministers and officials.

Also identified as relevant to your request are some briefings provided by DPMC's PAG to the Prime Minister. These briefings are provided to the Prime Minister in confidence to

support him in his role as leader of the Government and chair of Cabinet. These briefings are withheld in their entirety under the following sections of the Act:

- section 9(2)(a), to protect the privacy of individuals
- section 9(2)(f)(ii), to maintain collective and individual ministerial responsibility
- section 9(2)(f)(iv), to maintain the confidentiality of advice tendered by or to Ministers and officials
- section 9(2)(g)(i), to maintain the effective conduct of public affairs through the free and frank expression of opinion.

Where section 9 of the Act applies, in making my decision, I have considered the public interest considerations in section 9(1) of the Act. No public interest has been identified that would be sufficient to outweigh the reasons for withholding that information.

#### Information to be refused

DPMC does not hold any *memoranda or legal advice* on the PMSCA position. Accordingly, this part of your request is refused under section 18(g) of the Act as the information requested is not held, and I have no grounds for believing that the information is either held by another department or Minister of the Crown or organisation, or by a local authority; or connected more closely with the functions of another department or Minister of the Crown or organisation or of a local authority.

You have the right to ask the Ombudsman to investigate and review my decision under section 28(3) of the Act.

This response will be published on DPMC's website during our regular publication cycle. Typically, information is released monthly, or as otherwise determined. Your personal information including name and contact details will be removed for publication.

# Upcoming vacancy: Prime Minister's Chief Science Advisor | Kaitohutohu Mātanga Pūtaiao Matua ki te Pirimia

This is a unique role, providing independent expert scientific advice to the Prime Minister and other Cabinet Ministers, helping to improve the quality of scientific input into government policy, and convening and participating in discussions and debate on scientific matters, including in public.

## About this role | Mō tēnei tūranga mahi

The main priorities for the PMCSA are to promote understanding of science by policy makers, elected officials and the public, and to build understanding of where science can benefit New Zealand.

In practice, the PMCSA role is a broad one, with areas for project work agreed with the Prime Minister from time to time, and regular interaction with him or her. It typically includes:

- Providing scientific advice to the Prime Minister and Cabinet Ministers as requested
- Seeking to improve the quality of scientific input and information into policy
- Providing scientific input into crisis management situations and national security matters
- Being involved in public discussions and debate on scientific issues, and
- Convening the network of departmental science advisors.

Formally, the PMCSA role is a one-person Ministerial Advisory Committee to the Prime Minister, appointed through a Cabinet process for an extendable term of three years. The role becomes vacant on 1 July 2024.

## About you | Ko wai koe

A successful PMCSA will:

- Have a top-quality reputation in science, with a strong research and publication history, and good networks into the New Zealand science community
- Be able to lead the work of the office and collaborate across a range of scientific disciplines
- Be able to communicate effectively and to command respect, including at the highest levels of policy, in the science community, with business and civil society groups, and in the media, and
- Be able to, on occasion, represent New Zealand with distinction in international fora.

This position requires the ability to obtain and maintain a national security clearance at Top Secret level. In practice, this means that you must be a New Zealand citizen or hold a Resident class visa. Alternatively, you must be a citizen of the UK, USA, Canada or Australia with a 10 year checkable background.

- To undertake activities that enhance the use of science and evidence in policy formation and evaluation across government;
- To undertake a representational role from time to time, at the Prime Minister's request, and assisting in promoting New Zealand's interests internationally through science;
- To undertake activities that promote science and technology education;
- To comment on science issues (while observing the "no surprises" principle);
- To undertake specialist research on specific topics on which the Prime Minister has requested advice or commissioned reports;
- To undertake any other tasks or functions as agreed between the Prime Minister and the CSA from time to time; and
- To focus on issues and opportunities where science has the greatest potential to address issues faced by Maori and Pacific communities.
