Proposed Overseas Travel: Rt Hon Christopher Luxon, 15-22 March 2025

I seek Cabinet approval to undertake official travel to New Delhi and Mumbai, India, from 15 March to 22 March 2025 inclusive. My visit aims to enhance New Zealand's relationship with India – a priority country for us, and one critical to building and maintaining New Zealand's security and prosperity.

Purpose of Travel

2 I intend to travel to New Delhi and Mumbai, India, in support of the Government's strategy to transform our relationship with India, and in support of our economic growth plan. The objectives of the mission are:



Delegation

3.1

3 To reflect the seriousness with which the Government takes its relationship with India and the broad-based nature of that relationship, I propose to be accompanied by:

> Hon Todd McClay, Minister of Trade and Investment; Hon Mark Mitchell, Minister for Ethnic Communities; and Hon Louise Upston, Minister for Tourism and Hospitality;

- 3.2 A business delegation of around 40 business leaders from the primary industries, technology and digital, services and manufacturing, tourism and travel, investment and education sectors;
- 3.3 A community delegation of around 20 individuals who are active contributors to building the strong people-to-people links and cultivating enduring connections between our two countries, including four Members of Parliament;
- 3.4 A kapa haka performance group; and

- 3.5 Travelling New Zealand media.
- 4 Given the size of the delegation, the delegation will travel to India using Royal New Zealand Air Force Boeing 757s.

Outline of the visit

5 The mission to India is a high-profile element of the Government's strategy to transform New Zealand's relationship with India. s6(a)

My visit, with the sizeable supporting delegations, is an opportunity to add further momentum to this effort by demonstrating the depth of New Zealand's commitment to a broad-based and sustainable relationship. s6(a)

- 6 I intend to undertake the following engagements in New Delhi and Mumbai:
 - meetings with senior government leaders including Prime Minister Narendra Modi;
 - delivering the keynote address to India's Raisina Dialogue one of the world's preeminent conferences on security, geopolitics, and geoeconomics;
 - an event to showcase New Zealand as a high-quality destination for education;
 - events focussed on the Navy-to-Navy relationship;
 - a range of events to promote New Zealand tourism, sporting links, investment, and trade promotion.

Prime Ministerial Party

- 7 I will be accompanied by three staff from my office. The Minister for Trade and Investment, Minister for Ethnic Communities and Minister for Tourism and Hospitality will each be accompanied by a staff member.
- 8 Officials joining the mission will come from the Department of Prime Minister and Cabinet, Ministry of Foreign Affairs and Trade, New Zealand Trade and Enterprise, Ministry for Business, Innovation and Employment, Education New Zealand, Tourism New Zealand, and Sport New Zealand. Costs for officials will be met from within their respective agencies' baseline budgets.
- 9 I will also be accompanied by New Zealand Police Dignitary Protection Service staff, whose costs will be met by Vote Police.

Acting Ministers

- 14 If my travel is approved, I propose that Hon David Seymour act as Prime Minister and as Minister Responsible for Ministerial Services from 15-21 March; Rt Hon Winston Peters act as Prime Minister and as Minister Responsible for Ministerial Services from 21-22 March; and Hon Judith Collins act as Minister for National Security and Intelligence from 15-22 March.
- 15 Acting in Hon Todd McClay's portfolios will be Hon Nicola Grigg (Trade and Investment), Hon Mark Patterson (Agriculture) and Hon Tama Potaka (Forestry).
- 16 Acting in Hon Mark Mitchell's portfolios will be Hon Casey Costello (Police), Hon Chris Bishop (Sport and Recreation), Hon Paul Goldsmith (Corrections and Ethnic Communities) and Hon Simon Watts (Emergency Management and Recovery).
- 17 Acting in Hon Louise Upston's portfolios will be Hon Penny Simmonds (Social Development and Employment, Community and Voluntary Sector, and Child Poverty Reduction), Hon Matt Doocey (Disability Issues) and Hon Tama Potaka (Tourism and Hospitality).

Proactive release

18 This paper will be proactively released as per Cabinet Office Circular CO (18) 4 on the Department of Prime Minister and Cabinet's website. The paper will be subject to redaction as appropriate on the grounds set out under the Official Information Act 1982.

Recommendations

I recommend that Cabinet:

- 19.1 **Authorise** my absence from New Zealand from 15 to 22 March 2025, inclusive, to travel to New Delhi and Mumbai, India;
- 19.2 **Agree** that I be accompanied by Ministers McClay, Mitchell and Upston, three members of staff from my office and one member of staff from each of the three Ministers' offices, and one official from the Department of Prime Minister and Cabinet (DPMC).

- 19.3 **Approve** the estimated expenditure of s9(2)(f)(iv) for the travel expenses of the Ministerial party, as a charge to Vote Internal Affairs: Members of the Executive Travel.
- 19.4 **Note** that I will be accompanied by officials from the Ministry of Foreign Affairs and Trade, New Zealand Trade and Enterprise, Ministry of Business, Immigration, and Employment, Education New Zealand, Tourism New Zealand, and New Zealand Police - Dignitary Protection Services officers, whose travel costs will be met by respective agencies.
- 19.5 **Note** that I will be accompanied by a business delegation of approximately 40, a community delegation of approximately 20, a media delegation of approximately 16, whose costs will be met by them personally, and a kapa haka group, costs for which will be met through the Ministry for Culture and Heritage Cultural Diplomacy International Fund and private funding sources.
- 19.6 **Agree** that in my absence, Hon David Seymour act as Prime Minister and Minister Responsible for Ministerial Services from 15-21 March; Rt Hon Winston Peters act as Prime Minister and Minister Responsible for Ministerial Services from 21-22 March; and Hon Judith Collins act as Minister for National Security and Intelligence from 15-22 March.
- 19.7 **Agree** that in the absence of Minister McClay, Hon Nicola Grigg act as Minister for Trade and Investment; Hon Mark Patterson act as Minister of Agriculture; and Hon Tama Potaka act as Minister of Forestry.
- 19.8 **Agree** that in the absence of Minister Mitchell, Hon Casey Costello act as Minister of Police; Hon Chris Bishop act as Minister for Sport and Recreation; Hon Paul Goldsmith act as Minister of Corrections and Minister for Ethnic Communities; and Hon Simon Watts act as Minister for Emergency Management and Recovery.
- 19.9 Agree that in the absence of Minister Upston, Hon Penny Simmonds act as Minister for Social Development and Employment, Minister for the Community and Voluntary Sector, and Minister for Child Poverty Reduction; Hon Matt Doocey act as Minister for Disability Issues; and Hon Tama Potaka act as Minister for Tourism and Hospitality.
- 19.10 **Note** that the House is not sitting during my absence.
