### Report on Overseas Travel: Rt Hon Christopher Luxon - India, March 2025

I recommend Cabinet note this report of my travel to India from 15 to 22 March 2025. I was accompanied by the Minister for Tourism and Hospitality, the Minister for Ethnic Affairs, and the Minister for Trade and Investment.

## Report

- In what was this Government's biggest offshore mission yet, we spent five days in India, visiting both New Delhi and Mumbai. We achieved our objectives, namely:
  - To demonstrate to India's leadership that New Zealand is serious about building a dynamic but enduring partnership through strengthening connections across all sectors in the relationship. Together with the accompanying Ministers, I succeeded in establishing strong rapport with my political counterparts, demonstrating to Indian colleagues New Zealand's seriousness in committing to a comprehensive relationship. s9(2)(g)(i), s6(a)
  - ii To enhance our business-to-business, people-to-people and cultural ties in support of a broad-based relationship. Throughout the visit, I engaged with Indian business leaders, profiled our sporting ties (principally cricket, but also rugby), and learned more about the place of India's religions in its society. Led by Ministers Upston and McClay, a 40-strong business delegation joined the mission, meeting Indian counterparts. learning about the market opportunities, and intersecting with my programme to promote business opportunities. Led by Minister Mitchell, a 19-strong community delegation was a new and unique addition to a Prime Ministerial mission: it served to underline the people, cultural and sporting connections between our two societies. In addition, our two on governments agreed education and sports arrangements, and we promoted New Zealand as a tourist destination.

To position New Zealand to benefit from India's strong economic trajectory by promoting New Zealand education, technology and innovation, tourism, and agriculture cooperation. The launch on the first day of the mission of Comprehensive Free Trade Agreement negotiations was the biggest step forward in the NZ-India economic relationship in some decades, with a commitment to negotiate at pace. In addition, a series of education, tourism and primary industry promotional events were undertaken, with 33 commercial deals agreed

by participants in the business delegation. Horticulture, forestry and customs arrangements were signed between the two governments.

- To demonstrate our relevance to India as an engaged and credible Indo-Pacific partner on defence and security. The mission was designed to underline that New Zealand is an informed and active participant in the Indo-Pacific region through my keynote address at the Raisina Dialogue, the suite of deliverables for the visit (e.g. a Defence Cooperation Arrangement), and engagement between the two countries' navies.
- In addition to the success in our policy deliverables, the visit worked to reposition perceptions of New Zealand in India, as well as energising the narrative about India back home.

ii Second, the emphasis PM Modi and others placed on societal ties. The way the Indian diaspora has been embraced as part of New Zealand society was clearly noticed. PM Modi also emphasised the opportunity for India from high-performance sports cooperation s6(a)

and our education offering s6(a)

iii Third, s9(2)(g)(i)

, there is ample scope for export growth (India currently accounts for just 1.5 percent of our exports). India is the world's fifth largest economy, with the fastest GDP growth rate in the G20, and a middle class that already numbers 445 million. The FTA could be critical \$9(2)(g)(i) if we are to tap this potential.
