Report on Overseas Travel: Rt Hon Christopher Luxon – August 2025

I recommend Cabinet note this report on my travel to Papua New Guinea, which took place between 4 and 6 August 2025.

Report

1 In the first visit to Papua New Guinea by a New Zealand Prime Minister with an exclusively bilateral focus since 1984, I was able to spotlight our efforts with the largest and most populous of Pacific Islands countries in its 50th year of independence. Against that background, I was able to deliver on the objectives agreed by Cabinet for this travel, namely

1.1 Reiterate at the highest level the importance New Zealand attaches to our relationship with Papua New Guinea as we celebrate 50 years of diplomatic relations: With a state banquet hosted in New Zealand's honour and me being granted the rare honour of being the second foreign leader to address PNG's Parliament, a clear message was delivered by both sides about the friendship and respect we have for one another. Building on our history and Pacific connections, PM Marape's Government was restless to modernise our links reflecting a contemporary set of ambitions. ~~s6(a)~~

~~we will need to continue to find ways to lean in and support its aspiration to accelerate its economic growth and to become a link between Southeast Asia and the Pacific.~~

1.2s6(a) highlight New Zealand's value as a reliable and responsive partner across trade, economic and social development, and the security sector: In my formal bilateral meeting with PM Marape, he was accompanied by eight Ministers, with that an opportunity for a holistic review of all aspects of the relationship, identifying work we can do better to support PNG's economic development, enhance two-way trade and investment links, and strengthen PNG's policing. By visiting New Zealand Army and PNG Defence Force personnel training together and then the site of the eye health hospital being built by New Zealand, we were able to publicly profile the breadth and history of our connections.


1.3 Advance implementation of the New Zealand Papua New Guinea Statement of Partnership, including by announcing progress in economic cooperation: As part of our effort to reflect back to PNG its wish for New Zealand's public and private sectors to support its economic development, we gave this domain some focused attention. I took a small business

delegation to profile and explore deepening our commercial ties. We launched a five-year economic plan of action, committing to a set of meaningful activities to support economic growth across public enterprises, trade, agriculture, fisheries, labour mobility and business ties.

2 Combined with PM Marape's visit to New Zealand and Minister Peters visit to Port Moresby for the 50th anniversary celebrations, we have qualitatively stepped-up political engagement in a way that is creating genuine connection (e.g. with PM Marape going out of his way to meet me at Port Moresby airport on a Saturday night as I transited through in June 2024). s6(a)
